is in conflict with the law, but that is not the case in this case. The plea agreement clearly stated that the United States Attorney for the Eastern

---

District of New York would not file any additional charges against Rubel on the indictment on the basis that he had already been indicted in the Middle District of Florida. The defendant further argues that he is entitled to specific performance of his plea agreement and should be granted a withdrawal of his plea for the following reason: Rubel claims that he did not expect the court to



---

sentence him based on the Florida indictment. Rubel argues that it would be unfair to sentence him based on an indictment which was never presented to a grand jury or to a petit jury and for which he received no notice. The defendant also argues that he is entitled to specific performance because he was promised that he would be sentenced according to the terms of the Florida plea

---

agreement and the Florida plea agreement does not contain a provision for a maximum term of imprisonment. As stated above, I find that the defendant's petition should be denied. In my judgment, it is not in the public interest to allow a defendant to repudiate his plea agreement and then force the government to relinquish a valuable asset in exchange for the

---

defendant's plea of guilty. The government is no doubt astounded by the defendant's decision to make such a request at this late date. The defendant was not entitled to the specific performance he requested because he was not given reasonable notice that his plea would be based on the Florida indictment. Furthermore, the defendant has no expectation of receiving the same

---

sentence when he is sentenced in Florida pursuant to the plea agreement that he received in New York. In addition, the government did not make any promises to the defendant in the plea agreement, either orally or in writing, concerning the defendant's sentence. The government's promise, made in the plea agreement, was that it would not indict the

---

defendant or charge him with additional counts based on the indictment in the Middle District of Florida. In summary, I find that the defendant was not entitled to the specific performance he requested because: (1) the plea agreement did not state that the defendant would receive the same sentence for the crimes to which he pleaded guilty; and (2) the government made no promises to the
